Commemorate Calvin in Geneva

Calvin: His Life and Legacy

The rustic setting of the Machen Retreat and Conference Center, located in a remote Appalachian mountain area near McDowell, VA, was the site of a recent OPC ministers' conference on Calvin.

Dr. Cornelis P. Venema and Rev. Alan D. Strange spoke to about 15 conference attendees, including Mid-America alumni Rev. Tim McClymonds (2007) and Rev. David Robbins (2008).

Three OPC pastors, Rev. Brent Ferry, Rev. Dan Knox, and Dr. Richard Gaffin, Jr., preached at evening worship services.

Dr. Venema gave four addresses on Calvin: "Calvin's Life," Calvin's Legacy," "Calvin's Doctrine of the 'Twofold Grace of God," and "Calvin's Doctrine of the Imputation of Christ's Righteousness: Another Example of 'Calvin Against the Calvinists'?"

Rev. Strange dealt with Calvin's legacy in North America by first describing his influence in the British context up to the Westminster Assembly, and then dealing with three principal North American Calvinists: Jonathan Edwards, Charles Hodge, and J. Gresham Machen.

Dr. Venema says, "The conference was fairly intense and provoked a good amount of discussion."

Director John Jameson hopes the conference will become an annual event.



The spire of St. Pierre Cathedral dominates the center of Geneva, Switzerland, and visibly links the city to its famous citizen, John Calvin, whose theological impact is being celebrated in this 500th year of his birth.

Calvin preached in the Cathedral from 1536 to 1564. launching the biblical teaching that would influence and guide Reformed churches to this day.

Two Mid-America professors, Dr. Cornelis P. Venema and Dr. J. Mark Beach, were in Geneva May 28-30 to speak at the Sixteenth-Century Studies Conference (SCSC), which was held in Geneva to commemorate Calvin's 500th.

Dr. Beach spoke on "Calvin's Treatment of Gal. 3:15-22 and Its Implications for the Covenant of Grace: A Prelude to Federal Theology." He demonstrated how Calvin's exegesis of the passage (particularly the phrase from verse 16: "and to your seed, that is, Christ") informed and shaped subsequent Reformed tradition about the testamentary character of the covenant of grace. "Testamentary" here meaning "a bequested inheritance as a divine gift."

Dr. Venema spoke on "Union with Christ and the 'Twofold Grace' of God in Calvin's Theology: Comments on a Recent Debate." He addressed the relation between justification and sanctification (the two benefits or "double grace" of God), which is a question frequently discu⊠ssced among Calvin scholars.

"It may seem a little arcane," Dr. Venema says, "but it goes to the question of the continuity between Calvin's view and that of later Calvinists, and even the muchdisputed question today regarding the nature of faith in its office as instrument of justification."

The professors were among scholars from around the world who gathered in Geneva.

"It was wonderful to visit Calvin's Geneva and enjoy walks through the old city," says Dr. Venema, "including St. Pierre's where Calvin delivered most of his sermons and many of his lectures. However, it was disappointing to observe limited interest among SCSC participants in Calvin's legacy as a Reformed commentator, pastor-preacher, and theologian."

"Geneva is a beautiful city and the setting in which the city is situated is also majestic," says Dr. Beach. "Geneva has a much more multi-ethnic populace than I was expecting. With banners along the streets, the city was advertising (and thereby owning) their famous citizen, John Calvin. The museum about Calvin, set up on a temporary basis to celebrate his birth, was also impressive."

Willful Planning

n the last issue of the *Messenger*, we considered how philanthropy and stewardship differ. We said that philanthropic giving is characterized by the idea of giving what is *ours* for the sake of others; it is a humanistic approach to charitable giving. Stewardly giving, on the other hand, is characterized by the principle that our generosity seeks first the kingdom of God. It recognizes that all we have belongs to God and we serve as trustees of these resources for His kingdom (Matthew 25:14-30).

Since estate planning is a crucial part of godly stewardship, we will review several important aspects of it in future issues. Some years ago in the *Messenger*, we looked at several aspects of estate planning: needing an estate plan, setting priorities, planning basics, requiring a will, selecting an executor, explaining a revocable living trust, and

defining charitable gift annuities. In coming issues, I hope to expand on this previous series by examining wills and living trusts and a few issues in their creation and maintenance. Keep in mind that it is always important to obtain professional legal and tax planning advice when developing an estate plan.

Probably the most common motivator for writing a will is the birth of one's first child. Parenthood has a way of making us look to the future as perhaps nothing else can. Your will allows you to specify who will care for your children and manage their property if you are unable to do so.

If a parent dies before the children reach adulthood, the surviving parent usually assumes responsibility for children and property. When both parents die or a single parent dies, however, there is not another parent to assume responsibility. A will allows you to name a guardian for your children. If the court agrees that your choice is in the child's best interest, they will usually appoint this guardian as a surrogate parent. If both parents write a separate will, it is important to name the same guardian for each child. Covenant parents who view their children as a gift from God will want to select a guardian who will raise the children in the Lord. Leaving documentation regarding guardians may be especially important if you are concerned that the court may question your choice. Next time we will consider how your will relates to matters of property.

f you haven't browsed the Mid-America website lately, it's time to check it out. Abby Schaaf has revamped the site's appearance and added content in user-friendly menus.



Mid-America Reformed Seminary is pleased to announce the publication of two new books by Seminary President Dr. Cornelis P. Venema.


